



STANDARD WARRANTY STATEMENT

DENSO PRODUCTS AND SERVICES AMERICAS, INC. ("DPAM") warrants its EDGE COOL products only to the extent stated in its official written warranties. Unless otherwise specifically provided in writing by DPAM, DPAM warrants to the original end-user that the following product (the "Covered Product") shall be free of defects in materials and workmanship and will function in accordance with DPAM's published specifications under ordinary intended use and service for the period listed below beginning from the date of purchase on the invoice to the original end-user:

Warranty: 1 Year

DPAM shall, at its sole discretion, repair or replace the defective Covered Product. Such remedy shall be the end-user's sole remedy with respect to any particular defect in the Covered Product. This warranty does not cover defects in or malfunctions of the Covered Product that result from causes beyond DPAM's control, including, without limitation, (i) unusual physical or electrical stress on the Covered Product; (ii) accident, neglect, abuse, misuse, or other abnormal use of the Covered Product; (iii) failure to perform routine maintenance on the Covered Product in accordance with DPAM's recommended procedures; (iv) normal wear and tear; (v) repairs or attempted repairs to the Covered Product by a person not authorized in writing by DPAM; (vi) modifications or alterations to the Covered Product; (vii) use of the Covered Product with parts or devices not supplied or approved by DPAM; (viii) improper installation or service of the Covered Product; and (ix) shipping damage to any units or spare parts during shipping. This warranty shall cover only the Covered Product and shall extend only to the original end-user and shall be void if any labels or other identifying marks permanently affixed to products when shipped by DPAM are removed, altered, defaced, or obliterated.

TO THE EXTENT PERMITTED BY LAW, THIS WARRANTY, AS LIMITED HEREIN, SHALL BE IN LIEU OF AND EXCLUSIVE OF ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, ON THE PART OF DENSO PRODUCTS AND SERVICES AMERICAS, INC., WHETHER ARISING FROM LAW, COURSE OF DEALING, USAGE OF TRADE, OR OTHERWISE, INCLUDING, WITHOUT LIMITATION, ANY LIABILITY FOR COMMERCIAL LOSSES BASED UPON NEGLIGENCE OR MANUFACTURER'S STRICT LIABILITY. WE DISCLAIM ALL IMPLIED WARRANTIES, INCLUDING, WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. EXCEPT AS EXPRESSLY PROVIDED HEREIN, IN NO EVENT SHALL DPAM ASSUME ANY LIABILITY FOR INDIRECT, SPECIAL, INCIDENTAL, EXEMPLARY, OR CONSEQUENTIAL DAMAGES OF ANY KIND WHATSOEVER, INCLUDING, WITHOUT LIMITATION, LOST PROFITS, COSTS OF PROCESSING, INJURY, LOSS OF GOODWILL, BUSINESS INTERRUPTION, OR LOSS OF DATA ARISING FROM BREACH OF THIS WARRANTY REGARDLESS OF WHETHER ANY CLAIM IS BASED UPON THE THEORIES OF CONTRACT, NEGLIGENCE, STRICT LIABILITY, TORT, OR OTHERWISE.
